1 PURPOSE

1.1 The purpose of this procedure is to provide instructions regarding how the cord blood collection kit will be assembled by the laboratory staff.

2 INTRODUCTION

2.1 The laboratory staff will assemble the collection kit when a directed or autologous cord blood collection has been approved by the medical director. The collection kit will be sent directly to the mother or delivering physician.

3 SCOPE AND RESPONSIBILITIES

3.1 The medical director, laboratory manager, and designated laboratory staff are responsible for ensuring the requirements of this procedure are successfully met.


8 PROCEDURE STEPS

- 8.1 Collection Kit Assembly
 - 8.1.1 Obtain ISBT barcode from CCBB administrative staff. The CCBB administrative staff will release the barcode per procedure *CCBB-QA*-

009 ISBT Label Release. Assign one ISBT barcode set and complete the CCBB-QA-009 FRM1 CCBB ISBT Barcode Label Release Log. Record the name of the mother and the date next to the assigned ISBT barcode on the ISBT Barcode Label Release Log and indicate direct donor UCB blue box.

- 8.1.2 Pre label the following with an assigned ISBT maternal barcode (see pictures below for proper placement of ISBT numbers on test tubes):
 - 8.1.2.1 One 4 mL red-top (serum-clot) tube
 - 8.1.2.2 One 6 mL red-top (serum-clot) tube
 - 8.1.2.3 Two 6 mL lavender-top (EDTA) tubes
 - 8.1.2.4 One 5 mL PPT white-top tube (NAT)
 - 8.1.2.5 One 4 mL lavender-top (EDTA) tube





Do Not Cover Lot Number or Expiration Date with ISBT Label
