# **Duke University Adult Blood and Marrow Transplant Program**

The Adult Blood and Marrow Transplant Program at Duke University Medical Center was established in 1984 by Dr. William Peters, as an autologous transplant program. Initially, the program consisted of an eight bed inpatient unit, which was located on the 4th floor in Duke North Hospital. In 1988, the program moved into a new 16-bed inpatient unit (9200) which remains operative today. The unit was renovated in 2003. The program became a certified member of the National Marrow Donor Program (NMDP) in 1992. An outpatient treatment clinic was also established in 1992, as the program was one of the pioneers in providing outpatient treatment to blood and marrow stem cell transplant patients. Dr. Chao was recruited to Duke in 1996 to established an adult allogeneic program and direct the overall adult program. The administrative support space, outpatient treatment clinic and stem cell laboratory moved into a new, enlarged facility in 1997. In addition to the standard outpatient examination rooms, the clinic contains a seven day/week, 10 hour/day outpatient treatment facility in which outpatient transplant/supportive/infusional therapy is administered to patients recently discharged from the inpatient setting and some transplants are carried out in their entirety here. The outpatient clinic also has dedicated on-site laboratory and pharmacy support. The program coordinates outpatient care with local home infusion companies as determined by the patient's third party payer.

Originally, the program was staffed with 3 dedicated BMT physicians. Currently, the program is staffed with:

- 5 Transplant Coordinators
- 6 MD Advanced Practice Providers
- 3 Financial Coordinators
- 3 Financial Analyst
- 3 Social Workers
- 2 Oncology/ABMT Clinical Nurse Specialists
- 2 Clinical Pharmacist
- 1 Dietician
- Quality Manager
- 1 Programmer
- Data Managers
- Clinical Trials Assistants
- Data Technicians
- Clinical Research Coordinators
- 1 Patient Resource Manager/Discharge Planner
- 1 New Patient Coordinator
- 1 Donor Coordinators
- 1 Chaplain
- > 60 RNs caring for Adult SCT patients in the in- and out-patient settings

Currently, the program transplants 250+ patients a year ranging in age from 18-65+ years. Population specific competencies are an integral part of each individuals training program. Patients with adult diagnoses and/or adult developmental levels of functioning are cared for by the adult program.
