## STCL-SOP-049 JA1 AB SERUM TEST (AB CONTROL)

#### 1. PURPOSE

1.1. To provide instructions for staff in the performance of AB test controls when an AB test result is obtained.

#### 2. INTRODUCTION

## 2.1. Confirmation of AB Positive Blood Type

2.1.1. When patients are identified for the first time as AB positive, the AB control test is performed to distinguish between a true AB positive blood type and spontaneous agglutination caused by Wharton's jelly in cord blood samples or by heavily IgG-coated red cells.

#### 3. SCOPE

3.1. Designated laboratory staff processing cellular products will perform this testing. The Medical Directors and Laboratory Manager(s) are responsible for ensuring that the requirements of this procedure are successfully met.

#### 6.1. Reagents:

6.1.1. In-house AB control

#### 6.2. Supplies:

- 6.2.1. 12 x 75 mm test tubes
- 6.2.2. Disposable pipettes

#### 7. SAFETY

7.1. Wear all appropriate personal protective equipment when handling potentially hazardous blood and body fluids.

#### 8. PROCEDURE

- 8.1. Make a 4% red cell suspension.
- 8.2. Thaw an aliquot of 6% Albumin (this may be found in the designated laboratory freezer. Record the thaw date on the nunc vial and assign a 24 hour expiration date and time.
- 8.3. Add one (1) drop of the red blood cell suspension to two drops of the thawed aliquot of AB serum or 6% Albumin\*. Centrifuge (see calibration label on

centrifuge for appropriate time and speed), read and record results in the ABO/Rh logbook (ie. AB Control + or AB Control -).

- 8.3.1. If the AB control test fails to demonstrate agglutination (negative test), record these results in the ABO/Rh logbook.
- 8.3.2. If the AB control test demonstrates agglutination (positive test), spontaneous agglutination due to heavy coating of IgG or polyagglutination is likely. Consult Transfusion Services for additional testing recommendations (i.e. warm wash, DTT, testing with cord blood sera and/or lectins etc.).
- \* NOTE: 6% Albumin is prepared by mixing 17 mL of 25% Albumin with 33 mL of normosol saline. The sample is frozen in 1 ml aliquots, 50 tubes per batch. The rack is labeled to include the lot numbers and expiration dates of the normosol and albumin as well as the date prepared/frozen. No expiration date is assigned once the albumin suspension is frozen.
